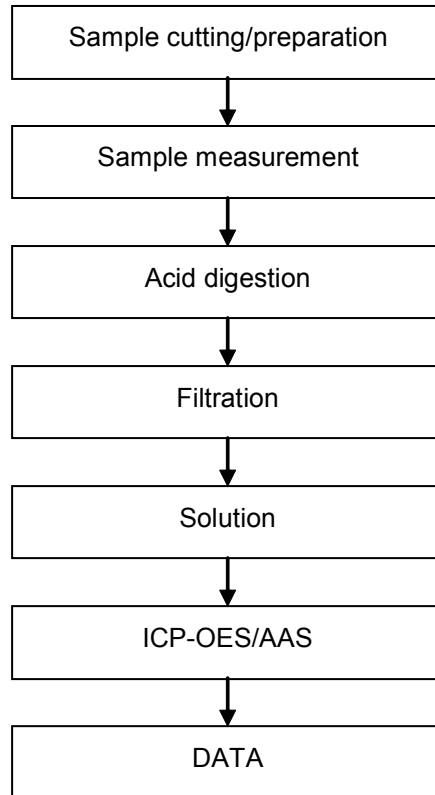

Elements Testing Flow Chart

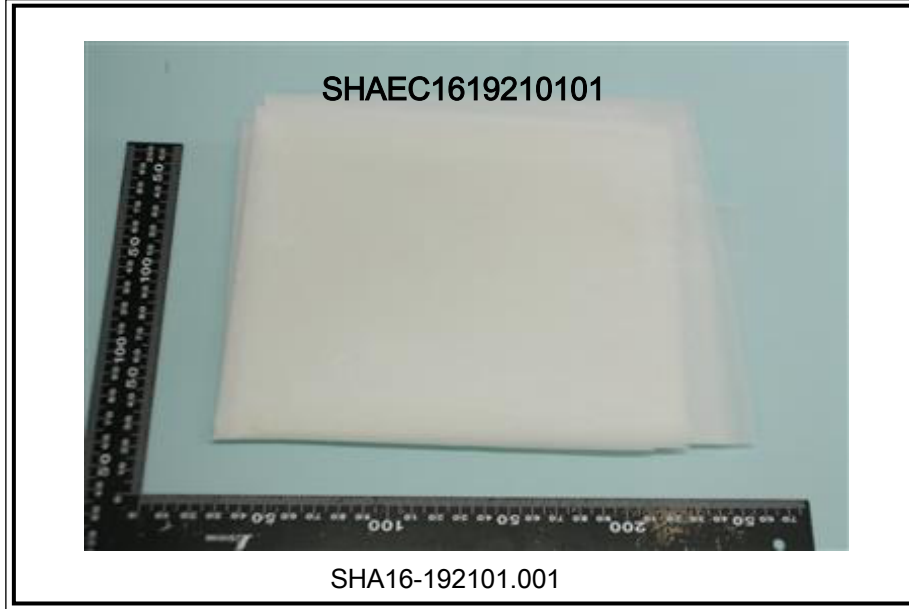
